#### 6. PLAYING FIELDS/RECREATION AREA

6.1 The ground is exceptionally wet and sodden at the moment.

#### 7. ROADS/FOOTPATHS

- 7.1 There is serious damage to the wildflower area in front of St Kenelms Church by 4 x 4 drivers. This is an important part of the parish's heritage, and a safe, effective but aesthetically appropriate solution is required to prevent this damage reoccurring in the future. Given that the historical accident record is low at this location the parish council is proposing the installation of suitable timber posts at 1.5m to 1.8m centres set at least one metre back from the road. The parish council is awaiting approval from Highways to install these posts.
- 7.2 The condition of the footpath on the brow of Romsley Hill was discussed. Vegetation overgrowth, fence posts and weather have caused significant damage to the pedestrian footpath that sits alongside the B4551. There are now multiple trip and uneven surface hazards over an extended section. The parish council is awaiting agreement from Highways to resurface this section of footpath as a matter of urgency.

## 15. **COUNTY COUNCILLOR**

#### Open for Business

Construction is about to start at the new Worcestershire Parkway Station. The area for the 500 space car park is now cleared and groundworks are complete, paving the way for construction to begin. The foundations are being laid now for construction of the main station building. The steel frame building will begin to take shape over the coming months as well as the footbridge over the railway line from Woodbury Lane. To support easy access to the station, a new roundabout is to be built and the road widened near the station site on the B4084. Work will continue until the end of September and temporary traffic lights will be in place.

## Children and Families

To support the move to an Alternative Delivery Model (ADM) for our Children's Social Care Services, a full business case will be presented

to Council Cabinet on 29<sup>th</sup> March. Following cabinet and subject to ministerial approval, work will then commence in April 2018 to plan the move to the new ADM, with the target of implementing the new model by 1<sup>st</sup> April 2019.

## Health and Wellbeing

The new interim Director for Adult Services, Avril Wilson has been appointed into the position and joined the council on 19<sup>th</sup> February. She has previously worked as both a Director of Adult Services and a Director of Children's Services and brings a wealth of experience to the leadership team. Avril lead on the roll out of the three conversations model in her previous role of Executive Director of West Sussex County Council.

#### The Environment

Work continues on two major flood alleviation projects around the County. At New Road, Worcester, Severn Trent are completing the diversion of a water main which is currently in the way of a planned new drainage culvert, and progress is being made on the installation of new drainage kerbage.

At Upton upon Severn, phase 1 of the road raising scheme is in full swing by the entrance to Upton Marina. The road and footway will be widening, straightened and raised, and a new right-turn lane provided into the Marina entrance. Traffic management will be reduced in spring and summer during the Upton and Three Counties shows and festivals.

Meanwhile on Worcester Southern Link Road, works are continuing in the vicinity of Battenhall Bridge, ready for the major widening when the railway line closes for five days in May.

## Council News Update

Council leaders across Worcestershire have agreed to relocate more Syrian refugees across the county. Worcestershire Leaders have agreed to host up to 50 Syrian refugees in Worcestershire. The aim is to resettle refugee families in different areas of the County. 50 refugees were resettled across Redditch, Wyre Forest and Worcester in 2016/17. This new commitment will bring the total number of refugees resettled under the Government's Syrian Vulnerable Persons Resettlement Scheme in Worcestershire up to 100.

It follows a decision by the leaders of Worcestershire County, Bromsgrove District, Malvern Hills District, Redditch Borough, Worcester City, Wychavon District and Wyre Forest District Councils at a recent meeting.

Finally, and sadly, you are probably already aware that our interim Chief Executive, Steve Stewart passed away last week. Steve joined the Council in May of last year and has made a big contention during his time with us. Steve had a career lasting more than 40 years in local government and was the Chief Executive at three different
